- ☹️ AS A PARENT, I WILL NOT HOLD OR THREATEN TO HOLD MY CHILD FROM PRACTICE OR COMPETITION AS A FORM OF PUNISHMENT.
- ☹️ I UNDERSTAND THAT ALL ATHLETES ARE REQUIRED TO WEAR THE APPROPRIATE PRACTICE ATTIRE TO EVERY PRACTICE AND APPROPRIATE DRESS CODE TO COMPETITION VENUES.
- ☹️ I UNDERSTAND THE IMPORTANCE OF ATHLETES MAINTAINING AND ATTEMPTING TO IMPROVE ON ALL SKILLS THAT WERE PERFORMED DURING TEAM PLACEMENT. I UNDERSTAND THAT PART OF SKILLS MAINTENANCE AND IMPROVEMENT WILL NEED TO BE OUTSIDE MY REGULAR PRACTICES IN THE FORM OF TUMBLING CLASSES, OPEN GYMS, PRIVATE LESSONS OR INDIVIDUAL FITNESS WORK.
